Rules and conditions

THE TOTAL NET PROCEEDS FROM THIS DRAW WILL BE EARMARKED FOR CHARITABLE PURPOSES

The Big draw runs from Tuesday, March 31, 2026, at 8 a.m. Montreal time (hereafter referred to as the “Opening Date of the Draw”) until Friday, July 10, 2026, at 11:59 p.m. Montreal time (hereafter referred to as the “Closing Date of the Draw”).

The FINAL DRAW will be held on July 13, 2026, at 1:00 p.m. at the offices of the Fondation Charles-Bruneau located at 4515 de Rouen Street, Montreal, (Quebec) H1V 1H1.

The Draw is in no way sponsored, endorsed, administered by, or associated with the Canadian Imperial Bank of Commerce (“CIBC”).

In order to meet the general conditions cited on the back of the Draw tickets, the Fondation Charles-Bruneau (hereafter referred to as the Fondation) has set out complete conditions for the 2025 Draw in this regulation.

DRAW REGULATION (RACJ: licence no. L-04465)

1. ELIGIBILITY

1.1 The Draw is intended for Quebec residents aged 18 or over, except for the members of the board of directors and permanent employees of the Fondation and of persons living with them.

1.2 The Fondation reserves the right to verify the age, identity, and place of residence of all persons claiming a prize.

2. HOW TO PARTICIPATE

2.1 The Fondation has made 15 000 tickets available for sale at a cost of \$15 each. Each ticket gives the Participant a chance to win one of the six (6) prizes described below, which have an approximate total value of \$21 300. Tickets are available at the Fondation (4515 de Rouen Street, Montreal), through its website at www.charlesbruneau.qc.ca/tirage, at CIBC banking centres from April 13 to July 3, 2026, and through persons authorized by the Fondation. The Fondation must receive payment for all online ticket purchases as well as the stubs from Draw tickets purchased in person by no later than the Closing Date of the Draw (July 10, 2026). Note that tickets will only be available for sale in Quebec.

3. DETAILS ON PRIZES

Each Draw ticket gives the holder a chance to win one of the six (6) following prizes. The Draw will be conducted in the following order:

3.1 The first ticket drawn will entitle the winner to win two (2) economic Class round-trip promotional tickets for travel anywhere Air Canada flies valued at approximately \$ 9 200 (depending on the date and your destination). These tickets are valid on Air Canada, Air Canada Express and Air Canada Rouge scheduled flights only.

- Travel is not permitted during the standard blackout periods, which are subject to change without notice. Please refer Appendix 1 to view the Blackout periods for promotional tickets.
- All applicable fees, such as airport/departure taxes, security charges or other third-party fees, taxes or charges are the sole responsibility of the bearer of the ticket.
- Travel using the Promotional Tickets must be completed by July 10, 2027.

The other terms and conditions of use for the prize will be included in the winner's certificate.

3.2 The second ticket drawn will entitle the winner to a RONA gift card valued at \$1,000.

The prize includes one (1) gift card worth \$1,000.

Redeemable at all participating RONA merchants. Please consult the FAQ link on the website www.rona.ca for additional information. The activation and/or use of this gift card constitutes acceptance of the terms and conditions set out below, which may be modified without prior notice by RONA Inc., in accordance with applicable laws. This card may be used up to its value (in Canadian currency) to make purchases at participating RONA banner stores and other banners designated by RONA Inc. It is non-cashable and non-refundable (subject to applicable provincial laws, if any) and may not be used to pay a credit account or credit card, to purchase other gift cards, or to make purchases on www.rona.ca. RONA Inc. and participating stores are not obligated to replace or honour this card if it is lost, stolen, or damaged. 3.3 The third ticket drawn will entitle the winner to a \$5 000 gift card redeemable in Tanguay:

The prize includes one (1) \$5 000 gift card.

Use this gift card up to its value to pay for your purchases at all Tanguay, Maurice Tanguay Signature, Tanguay L'Entrepôt stores, or by phone at 1-800-TANGUAY and on the website Tanguay.ca. Activation and use of this card constitute acceptance of the following terms: this card, in Canadian currency, is redeemable only for the purchase of taxable merchandise or services, is non-cashable, and non-refundable (subject to applicable provincial laws, if any). Tanguay is not obligated to replace or honor this card if it is lost or stolen. This card has no value until activated by Tanguay. There is no expiration date for the use of this gift card.

3.4 The fourth ticket drawn will entitle the winner to a package at Station Mont-Tremblant, valued at approximately \$1,400

One (1) package of two (2) nights for two (2) people in a hotel room at L'Ermitage du Lac, Les Suites Tremblant, parking and continental breakfast as well as 2 rounds of golf for 2 people, valid from Sunday to Friday during the summer of 2026.

The package cannot be redeemed on the following blackout dates: Thanksgiving weekends, Easter, Labour Day, World Cup, Holidays, American, Ontario and Québec spring breaks, Ironman and the Blues Festival.

3.5 The fifth ticket drawn will entitle the winner to a \$1,000 in IRIS gift card:

The certificate holder must present the Gift Certificate at the time of purchase and provide valid identification. Valid at all IRIS boutiques in Canada. Not transferable for cash or for another gift card. Not applicable to the cost of professional procedures or services. Dr. Jahel St-Jacques, optometrist.

3.6 The sixth ticket drawn, offered by the Seigneurie du Triton, will entitle the winner to a “Le Pêcheur en départ PM” package, with an approximate value of \$4,700.

The prize includes a three (3)-night stay for four (4) persons, including fishing rights, a boat, a motor, fuel, fish cleaning, trout smoking and technical assistance provided throughout the entire territory.

The package includes all meals, from dinner on the day of arrival until lunch on the day of departure. Breakfasts are served buffet-style, lunches at the *Shore Lunch* grill and dinners as a four (4)-course table d'hôte.

Accommodation is provided in an inn, in two (2) rooms, each with a private bathroom. Winners will also have access to various activities offered on the site, including canoeing, kayaking, swimming and other activities available on the premises.

The package is valid between June 21 and August 17, 2027. Arrival is permitted as of 4:00 p.m. and departure must take place no later than 3:30 p.m.

4. DRAW

4.1 The Draw will be held on Monday, July 13, 2026, at 1:00 p.m. Montreal time, at the offices of the Fondation Charles-Bruneau (4515 de Rouen Street, Montreal).

The Draw will include all participants who purchased an entry ticket via the Internet or at CIBC banking centres and who have paid for their ticket. For online ticket purchases, payment must be made prior to the Closing Date of the Draw (July 10, 2026, 11:59 PM).

4.2 Chances of winning. The chances that a Participant's ticket will be selected depend on the number of tickets sold during the Draw period, on a total of 15 000 tickets.

5. CLAIMING OF PRIZES

5.1 Winning ticket numbers will be posted on the Grand Draw website on July 14, 2026, at 1:00 PM. The Fondation will contact each Winner within ten (10) business days of the Draw date. Each Winner must sign a document attesting that he or she has taken possession of his or her prize under the conditions cited in this regulation and exempting the Fondation, its sponsors and their respective administrators, directors, employees, representatives and agents from liability stemming from loss, damages, claims, demands, actions, procedures, liabilities, expenses and costs and from obligations of any nature or kind incurred or engaged in by the Winner or any other person in relation to the draw or the prize.

5.2 If it is not possible to contact the selected Participant within ten (10) business days or if the Participant refuses the prize, the selected Participant will not be entitled to his or her prize and the Fondation may proceed with another Draw to select another Participant for the prize in question. The Participant's non-compliance with one of the conditions mentioned above or with any other condition set out in this regulation will entail the disqualification of the said Participant.

5.3 In each instance where a prize is claimed, the Fondation will present the prize solely to the person whose name is featured on the Draw ticket (paper or electronic version) or to any other person designated in writing by the said Winner.

5.4 In the event that a Participant selected for a prize is deemed ineligible to take part in the Draw, he or she will be disqualified. The Fondation will thereby refer the matter to the *Régie des alcools, des courses et des jeux*, which will determine how to attribute the prize. Such a procedure will not affect the attribution of the other prizes.

The Fondation will therefore refer the matter to the *Régie des alcools, des courses et des jeux*, which will determine how to attribute the prize in question.

5.7 Any conflict will be referred to the *Régie des alcools, des courses et des jeux*, and its decision will be final.

6. EXCLUSION OF LIABILITY

CIBC makes no warranty, guaranty or representation of any kind concerning any prize and disclaims any implied warranty.

7. PERSONAL INFORMATION

7.1 During the process of purchasing a ticket, the Participant will be invited to authorize the Fondation to use his or her name, photograph, likeness, voice and/or declarations concerning his or her prize for advertising purposes or for any other purposes related to the activities of the Fondation, with no form of remuneration.

8. COMPENSATION BY THE PARTICIPANT

8.1 By taking part in the Draw, the Participant shall:

- Waive his or her right to hold liable the Fondation, its parent companies, affiliates, partners, suppliers and sponsors, as well as their advertising agencies and directors, managers, employees, representatives and agents for any injury, loss or damage to the Participant or any other person, including personal injury, death, or property damage stemming in whole or in part, directly or indirectly, from the acceptance, possession, use or abuse of the Prize, from participation in the Draw, or from any violation of this regulation or activity related to the Prize;
- Agree to fully compensate the Fondation, its parent companies, affiliates, partners, suppliers, and sponsors, as well as their advertising agencies, directors, managers, employees, representatives, and agents for any claims made by third parties related to this Draw, without restriction.

9. MISCELLANEOUS

9.1 The companies whose products are offered as prizes and mentioned above are in no way associated with this Draw and under no circumstances may they be held liable for the progress of the Draw or for any other aspect of it.

9.2 The Fondation and the other beneficiaries of the exclusion of liability will not be liable for letters and entry forms that are illegible, incomplete, lost, forwarded to the wrong address or late; such letters or entry forms will be deemed invalid.

9.3 The Fondation reserves the right, at its sole discretion, to exclude from this Draw and from any subsequent Draw or promotion held by the Fondation, any person guilty or suspected of tampering with the processing of codes or the progress of the Draw or the Draw website; of acting in breach of this regulation or in an underhanded manner or a manner that hinders or is intended to importune, torment, threaten or harass

another person. Any attempt to deliberately damage the Draw website or any related website or to damage the legitimate progress of this Draw shall constitute a violation of criminal and civil laws. Under such circumstances, the Fondation shall have the right to initiate legal proceedings for damages, based on the scope of the liability provided for under law.

9.4 Without prejudice to what is otherwise set out in this regulation, all decisions of the Fondation and the organization overseeing the Draw are final and without appeal in regard to all components of the Draw.

Participation in this Draw entails the acceptance of this regulation.

10. RECOURSE TO THE *RÉGIE DES ALCOOLS, DES COURSES ET DES JEUX DU QUÉBEC*

A dispute concerning the organization or management of the Draw may be submitted to the *Régie des alcools, des courses et des jeux du Québec* for adjudication. A dispute concerning the attribution of a prize may be submitted to the *Régie* solely for purposes of an intervention aimed at resolving it.

11. LANGUAGE

In the event of a discrepancy between the French and English versions of this regulation, the French version shall prevail.

12. SEVERABILITY OF PARAGRAPHS

If a paragraph in this regulation is declared or judged illegal, unenforceable, or invalid by a competent court, the paragraph in question will be deemed invalid, though all of the other paragraphs that are not affected will apply within the limits permitted by the law.

13. INTELLECTUAL PROPERTY

All intellectual property and all promotional material, Web pages and source codes are the property of the Fondation or its affiliate, except for the intellectual property owned by CIBC. Copyright. The unauthorized copy or use of material protected by copyright or of trademarks without the expressed written consent of its owner is strictly forbidden.

14. FINAL PROVISION

This constitutes the official regulation of the Draw. This Draw is subject to federal, provincial, and municipal laws and regulations. Where required, the regulation governing this Draw may be modified without prior notice with the consent of the *Régie*, to render it compliant with all federal, provincial or municipal laws or with the policy of any entity with the competence to govern the Fondation.
